Modern Slavery Statement 2024



An update from the Chief Executive

This year, here, at the Blue Cross we have continued to improve our practices to combat slavery and human trafficking. This statement sets out the steps that Blue Cross and its wholly owned subsidiary companies, are taking to try and ensure modern slavery is not taking place in our business or supply chains and is made pursuant to Section 54 of the Modern Slavery Act 2015. We strive to act ethically and with integrity in all of our business dealings and relationships to minimise the risk that modern slavery is taking place anywhere in our own business or in any of our supply chains. We shall also ensure our approach and stance is clear with our partner organisations. This statement covers Blue Cross and its two wholly owned subsidiaries, Blue Cross Trading Company Ltd and Blue Cross (D&B) Company Ltd

Organisational structure

We are a charity dedicated to helping sick, injured, abandoned, unwanted or homeless pets. Thousands of pets turn to us for help every year.

We are governed by a Board of Trustees who volunteer their time to help direct our work. They oversee our Directors who manage our 798 staff and 2,446 volunteers across the whole charity. We have two wholly owned trading subsidiary undertakings.

Supply chains

We have a variety of supply chains that provide goods, services and works to support the delivery of our frontline services as well as enabling internal functions to deliver services within the organisation. The vast majority of our suppliers and contractors are based in the UK or the EU. We acknowledge that there may be modern slavery occurring in our supply chains that we are not aware of and we are committed to continuously improving our processes and procedures to identify, reduce and eliminate this wherever possible.

Our policies on anti-slavery and human trafficking

We are committed to working towards ensuring that there is the lowest possible risk of modern slavery or human trafficking in our supply chains or in any part of our business. We have developed an Anti-slavery and Human Trafficking Policy, which reflects our commitment to acting ethically and with integrity in all of our business relationships. We will treat any breach of our Anti-slavery and Human Trafficking Policy very seriously.

We are also continuing the process of developing, effective systems and controls to minimise the risk that slavery and human trafficking is taking place anywhere in Blue Cross or our supply chains.

Supplier adherence to our values and ethics

We believe it is important that our approach to procurement ensures alignment with our values and that suppliers meet the standards we expect from an Environmental, Social and Governance perspective. Following the commitments made in previous statements we have been continuing to monitor and improve our procurement approach. In addition to our own procurement policy and toolkit to guide this work, the UK public procurement service Crown Commercial Services is now actively being used for procurement exercises. In addition to this we have recently investigated and used the Business Social Compliance Initiative (BSCI) to perform checks on suppliers that are of higher risk in terms of global supply chains. We intend to continue using this service for these auditing purposes and to comply with the BSCI Code.

Blue Cross' continued commitment

We recognise the importance of maintaining constant vigilance to identify and address any issues associated with slavery and human trafficking in Blue Cross and throughout our supply chains. We are committed to continuing to enhance our capacity to identify, prevent and mitigate any actual or potential risks in these areas. This includes communications through various channels to staff and also the ability to report concerns through our Whistleblowing process.

This statement is made pursuant to section 54 (Part 6) of the Modern Slavery Act 2015 and constitutes Blue Cross' slavery and human trafficking statement for the financial year ending 31st December 2023. It has been approved by the Board of Trustees and is signed by Chris Burghes the charity's Chief Executive.
